A 10-question test is offered at the conclusion of each module to check your understanding of the module.

You may choose to complete the entire *FIT* program, sign on to either the clinician or the clinical administrator tract, or take courses in specific topic areas such as Screening and Assessment, Stagewise Treatment, and Motivational Interviewing. This program is also incredibly flexible; CEs are awarded for each topic area, or group of modules, completed.
